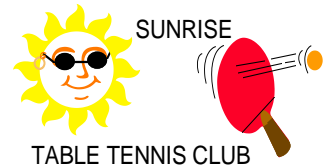

The current economic conditions are reducing those donations while the same economic conditions are increasing the need for such programs. These conditions, with the added burden of reduced community resources, require us to search our funding from corporate sponsors who have an interest in their community.

Since we became a 501(c)(3) in 2004, our major services to the community have been:

- Summer Camp Clinics, After School Programs and Tournaments for approximately 1,500 youth
- Family Grants for recreational activities, of \$600
- Collegiate Scholarships, totaling \$5000
- Provided equipment and training at no cost to the University of South FL, various Churches, Boys and Girls Clubs and Recreation Centers at fourteen locations with fifty table tennis tables, including balls and paddles.
- Established a program which provided equipment at Oak Grove Middle School in Clearwater FL
- Subsidized senior training programs
- Volunteer Program Hours of approximately 12,000 hours
- No Paid Staff at SSF and STTC; (volunteers hours above do not include SSF/STTC hours)
